

BY IDENTIFYING AND HONORING EXCELLENTLY MANAGED ORGANIZATIONS IN OUR AREA, THE AWARDS ALSO AMPLIFY AND PUBLICLY RECOGNIZE THE IMPACT OF THE LARGE AND DIVERSE NONPROFIT COMMUNITY IN NEW YORK CITY, LONG ISLAND, AND WESTCHESTER. EACH CYCLE OF THE PROGRAM SPANS PARTS OF TWO FISCAL YEARS. THE FIRST QUARTER OF THE FISCAL YEAR IS THE END OF THE PRIOR YEAR'S AWARDS AND CULMINATES WITH THE AWARDS PRESENTATION AND BEST PRACTICES CONFERENCE. THE REMAINDER OF THE FISCAL YEAR IS THE BEGINNING OF THE NEXT YEAR'S PROGRAM AND FOCUSES ON EDUCATION AND APPLICATION PROCESSES.

THE 2017 AWARDS PROGRAM CULMINATED IN DECEMBER 2017 (FY18) WITH THE ANNOUNCEMENT OF 3 WINNING ORGANIZATIONS - BROOKLYN COMMUNITY SERVICES (BCS), CHILDREN'S AID, AND GAY MEN'S HEALTH CRISIS (GMHC) (SCHEDULE I) - AT A SPECIAL BEST PRACTICES WORKSHOP AND AWARDS PRESENTATION. THE EVENT WAS ATTENDED BY 284 NONPROFIT LEADERS, BOARD MEMBERS, FUNDERS, CONSULTANTS AND OTHERS, 93% OF WHICH REPORTED LEARNING NEW MANAGEMENT IDEAS OR STRATEGIES THAT THEY INTENDED TO APPLY TO THEIR WORK. THE WINNING ORGANIZATIONS RECEIVED CASH AWARDS TOTALING \$60,000 AND SCHOLARSHIPS FOR THE COLUMBIA BUSINESS SCHOOL EXECUTIVE EDUCATION PROGRAMS IN SOCIAL ENTERPRISE. THE AWARDS PROGRAM WAS FOLLOWED UP BY

EIGHT PATHWAYS TO EXCELLENCE WORKSHOPS, EACH EXAMINING A DIFFERENT AREA OF NONPROFIT MANAGEMENT, HELD IN JANUARY 2018.

THE 2018 AWARDS PROGRAM BEGAN IN MARCH 2018 AND ENDED DECEMBER 2018 (FY19). AFTER A SERIES OF THREE APPLICATION CLINICS, NPCC RECEIVED 36 QUALIFIED PART ONE APPLICATIONS, WHICH WERE REVIEWED BY A 30-MEMBER EXPERT SELECTION COMMITTEE REPRESENTING DEEP AND BROAD KNOWLEDGE IN THE EIGHT KEY AREAS OF NONPROFIT MANAGEMENT THAT GUIDE THE PROGRAM. NPCC PROVIDED FEEDBACK TO AWARDS APPLICANTS BASED ON DETAILED SCORING OF THEIR APPLICATIONS BY THE SELECTION COMMITTEE. FOURTEEN SEMIFINALISTS, SELECTED FROM THE ORIGINAL POOL, SUBMITTED A PART TWO APPLICATION. THREE FINALISTS WERE SUBSEQUENTLY SELECTED TO MEET WITH THE SELECTION COMMITTEE, WHICH ULTIMATELY CHOSE ONE WINNER FOR OVERALL MANAGEMENT EXCELLENCE - SAFE HORIZON - WHICH WAS ANNOUNCED IN EARLY DECEMBER 2018.

FOR THE 2018 AWARDS, NPCC WORKED TO ENSURE THAT THE PROGRAM WAS ACCESSIBLE TO ORGANIZATIONS OF ALL SIZES AND REPRESENTATIVE OF THE DIVERSITY OF THE AREA'S NONPROFIT SECTOR. AS PART OF THIS IMPORTANT WORK, NPCC INTRODUCED SEPARATE PRIZES FOR THE ORGANIZATIONS THAT DEMONSTRATED EXCELLENCE IN THE PROGRAM'S GUIDING EIGHT KEY AREAS OF NONPROFIT EXCELLENCE: THE OSBORNE ASSOCIATION, ST. NICK'S ALLIANCE, LITERACY INC., GRAND STREET SETTLEMENT, DAY ONE, SAFE HORIZON, EDUCATION THROUGH MUSIC, AND CENTER FOR URBAN PEDAGOGY. THIS WORK AND THE ACCOMPANYING ACCOMPLISHMENTS WILL BE REPORTED ON THE FY19 990.

EDUCATION AND TRAINING:

WORKSHOPS:

NPCC'S TRAINING PROGRAM IS DESIGNED TO GIVE PARTICIPANTS MUCH NEEDED TECHNICAL AND MANAGERIAL EXPERTISE AND INFORMATION IN THE EIGHT KEY AREAS OF NONPROFIT EXCELLENCE. WE BELIEVE THAT THE STRONGER ORGANIZATIONS ARE IN THESE KEY MANAGEMENT AREAS, THE MORE LIKELY THEY ARE TO BE HEALTHY, SUSTAINABLE, AND ABLE TO ADOPT TO CHANGING TIMES. IN FY18, NPCC PROVIDED A TOTAL OF 78 IN-PERSON WORKSHOPS, FORUMS, AND WEBINARS WITH THE GOAL OF PROMOTING MORE EFFECTIVE MANAGEMENT THROUGH PARTICIPANTS' INCREASED UNDERSTANDING AND IMPLEMENTATION OF EXCELLENT MANAGEMENT PRACTICES. A TOTAL OF 2,153 INDIVIDUALS ATTENDED NPCC'S TRAININGS AND RATED THE WORKSHOP CONTENT AN AVERAGE OF 4.3 ON A 5-POINT SCALE.

LEARNING LABS:

NPCC'S LEARNING LABS ARE A TRAINING SERIES CONSISTING OF 6-MODULE COHORT-BASED SESSIONS THAT PROVIDE PARTICIPANTS WITH SKILLS- AND TOOLS-BUILDING IN SPECIFIC AREAS OF MANAGEMENT EXCELLENCE WITH THE GOAL OF OFFERING THEM MORE COMPREHENSIVE, APPLICABLE, AND IMPACTFUL PROGRAMMING. IN FY18, NPCC OFFERED LEARNING LABS IN THE AREAS OF RESULTS AND IMPACT, AND GOVERNANCE. THESE LEARNING LABS WERE ATTENDED BY 44 PARTICIPANTS, REPRESENTING 27 UNIQUE ORGANIZATIONS. ACROSS THE TWO SERIES, 85% OF PARTICIPANTS REPORTED THAT THE KNOWLEDGE THEY GAINED WOULD IMPROVE THEIR ORGANIZATIONS. NPCC ENGAGES NONPROFITS TO COLLECTIVELY BUILD A MOVEMENT THAT SERVES TO PROTECT AND PROMOTE THE NONPROFIT SECTOR'S ABILITY TO SURVIVE AND THRIVE. NPCC CHAMPIONS THE NONPROFIT SECTOR AND ADVOCATES FOR NONPROFITS AND POLICIES THAT CREATE A SAFE, INNOVATIVE, EQUITABLE, AND EFFECTIVE SECTOR. NPCC CONVENES AND ORGANIZES NONPROFIT LEADERS TO USE THEIR EXPERTISE ON BEHALF OF THE ENTIRE SECTOR TO ADDRESS SYSTEMIC, POLICY, AND REGULATORY ISSUES MOST IMPACTING NONPROFITS.
