

2017 NONPROFIT SALARY SURVEY REPORT

Executive Summary



Introduction

The NPCC Salary Survey Report is a tool to help inform and assist nonprofit organizations in New York City, Long Island, and Westchester assess their salary scales and make adjustments where necessary. This report outlines the results from a survey conducted from March 2017 through April 2017. Salary information requested was for current base annual salaries (not including benefits, cash bonuses, etc.) for full-time employees. The survey listed positions with one-sentence descriptions in common nonprofit departments/areas: administrative, advocacy, communications/marketing, facilities, financial management, fundraising, human resources, leadership, legal, measurement and evaluation, programs, and technology. Survey participants wrote in the salaries for the positions that exist within their organizations. The survey was sent to some 1,300 contacts via email and we received 309 completed responses.

In this executive summary, the salary responses are displayed in the aggregate and by department. The data are presented in a table and provide information on:

- The number of respondents per position (N=)
- The average
- The median, or the figure that falls in the middle, where 50 percent of respondents make less and 50 percent make more
- The 25th and 75th percentile, which are calculated by arranging the salary values from lowest to highest and determining the points where these percentages fall

For the results broken down by operating budget size and by organization type or sub-sector, you will have to download the full report.

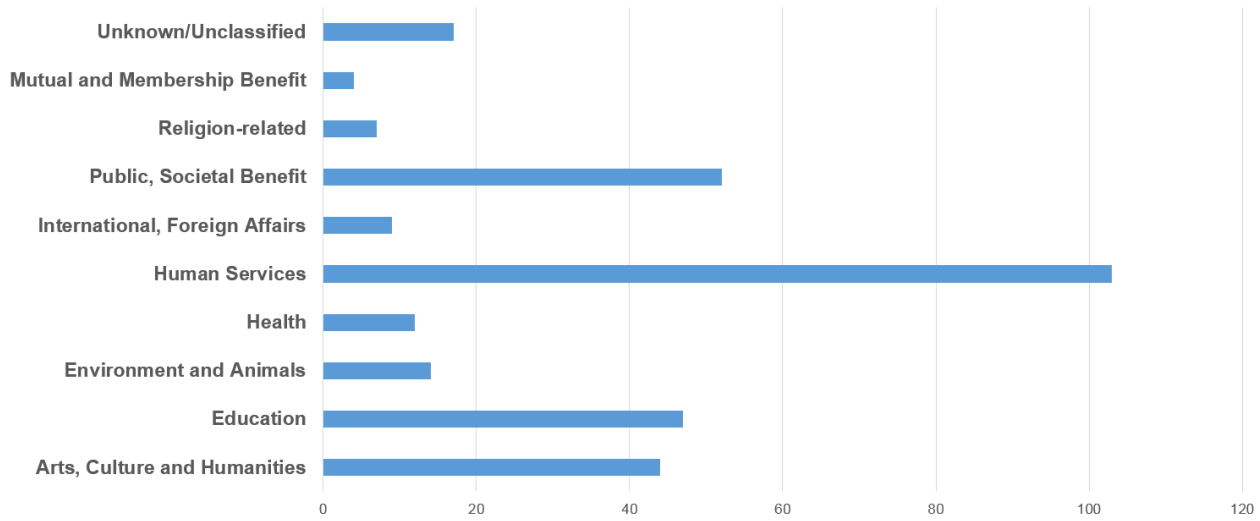

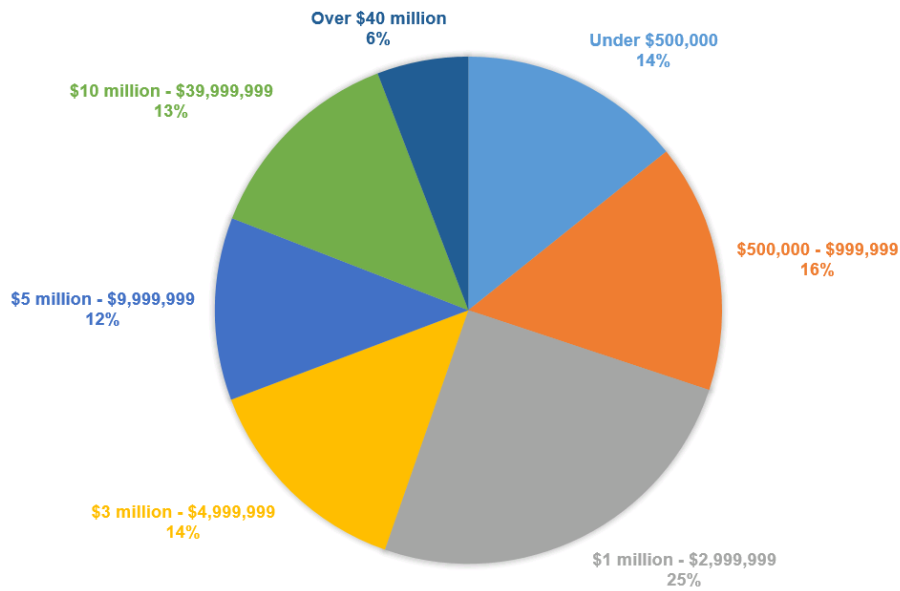


Respondent Data
